ABOUT THE GUNPOWDER WATERSHED

Since 1989, we have maintained conservation easements on over 1,600 acres of land, planted more than 30,000 trees on over 170 acres, distributed more than 500 rain barrels conserving millions of gallons of water, coordinated 700 stream clean-ups, and recruited more than 26,000 dedicated volunteers to protect and restore the land and waterways of the Gunpowder watershed.

The Gunpowder watershed drains 500 square miles from its starting point in lower York County, PA sweeping through Baltimore, Carroll and Harford Counties in Maryland before reaching the shores of the Chesapeake Bay. The Gunpowder River is 53 miles long and has two main branches: Big Gunpowder Falls and Little Gunpowder Falls.

Protecting land adjacent to the Gunpowder River and its tributaries is critical to sustain water and air quality for fish and wildlife habitat. In addition, the majority of the Baltimore metropolitan area water supply comes from two reservoirs located within the Gunpowder watershed: Prettyboy Reservoir and Loch Raven Reservoir.



2018 GUNPOWDER VALLEY CONSERVANCY LAND PRESERVATION REPORT



"We believe that the first thing that interested us about the farm at Bird River Beach was the great potential to be an oasis in an area that was continuing to be overdeveloped. We saw the beauty in the land that with a little love and a lot of hard work it could be thriving again as a natural setting. With the help of the GVC and lots of volunteers, relatives, friends and neighbors our dreams are coming true. To date we have finished a 10 year grading restoration project, planted hundreds of trees, pond enhancements and wildlife habitat creations.

Some of the projects that are ongoing are wood duck and bluebird nest boxes, honey bees, organic farming and wildlife food plantings. We welcome visitors and new natural enhancement ideas. Having a property in a GVC easement has been a partnership that has made a true oasis for us and future generations".

The Gunpowder Valley Conservancy's land preservation program encourages land owners to place their properties in conservation easements topreserve the environment and natural resources – the ecosystem that sustains our lives, and the agricultural, recreational, historic and scenic resources in perpetuity for future generations.

Our priority areas are currently located in the Gunpowder Rural Legacy Area, along the Gunpowder Falls from Sparks into White Hall, Maryland, and the Coastal Rural Legacy Areas, along Middle River and the Bird River watersheds. Currently, GVC has 34 properties totaling 1606 acres in conservation easements, with the goal of preserving 2000 acres by 2020.

In 2018, we continued to communicate to landowners the values of preserving land through outreach and an "Easement 101" workshop that was held to educate people on the opportunities available to place their land in a conservation easement. We also monitored preserved properties in the Gunpowder Rural Legacy area and encouraged landowners to engage with their neighbors to consider placing their land in an easement. In 2018, GVC was awarded a grant from the MD Department of Natural Resources Rural Legacy Program for \$720,000 to be used to purchase easements in the Gunpowder Rural Legacy Area. Thanks to our Land Preservation Director, Ann Jones, we have also submitted through Program Open Space funding to purchase an easement on a property that is contiguous with the Gunpowder River and the NCR trail.

We appreciate the commitment of the current owners of the lands that are in easements. Two of our property owners, Victoria and Norm Sines, have a 77-acre property in easement in the Bird River Watershed. This property was originally a quarry used for aggregate for the building of roads into the coastal areas. They shared their passion for living on a preserved property in the quote at left.

THE RIPPLE EFFECT OF THE CLEAR CREEKS PROJECT

t all started in 2012 with a shared desire to restore clean, clear water to the waterfront communities along the Middle River and Tidal Gunpowder. Residents vividly recalled a time when the water was so clear that you could see your feet in the creeks. Water quality has degraded as increased development and impervious (hard) surface prevent stormwater from soaking back into the ground. Stormwater runoff is one of the leading sources of water pollution, however, the problem can be tackled through partnerships with local government, nonprofits, businesses, faith-based communities, individual residents, and other stakeholders.

The Gunpowder Valley Conservancy's Clear Creeks Project: Our Water, Our Heritage, Our Pride launched in 2013 as a result of the citizen-based initiative to educate the public how to implement bay-friendly practices on their property to restore water quality. Thanks to our grant funding for the past five years, we have provided homeowners, businesses, and other institutions in our project area with 50 – 80% discounts on such practices as rain barrels and rain gardens. A lot of individual actions really do add up!

The Clear Creeks Project has expanded further upstream to include the Bird River watershed in 2015 and Lower Gunpowder Falls (LGF) watershed in 2018. With a 46-square mile drainage area and almost 200 stream miles, the LGF offers many opportunities for people to connect to water, whether it be an unnamed creek behind a townhome community or along the banks of the beautiful Big Gunpowder Falls. We're happy to report that LGF residents and organizations have quickly become active participants in the Clear Creeks Project with thirty-six rain barrels sold and nine conservation gardens installed, including two Bayscapes and seven rain gardens. In 2018, twenty percent of all Clear Creeks Project volunteers lived in the LGF watershed.

Now over five years after the project launch, we can take a step back and truly see how individual actions through the Clear Creeks Project have had a larger impact on educating the public about reducing stormwater runoff.

A model community: In 2016, the Miramar Landing community (Middle River) earned the distinction of becoming the first HOA in Baltimore County to have its community property certified as a Bay-Wise landscape through the UME-Baltimore County Master Gardeners after many stormwater best management practices were installed by GVC. It is now considered a case study for municipal stormwater management in the Chesapeake Bay region.

"We had just moved into our home in Parkville and wanted to replant native plants in the abandoned gardens to attract bees, birds, and butterflies. Our old home had a fantastic following among bees and lightning bugs. But the first summer was exceedingly wet, and our dream of a garden became an urgent concern about too much standing water in the back, and an almost river on the side. On researching how to improve the drainage, we came across information about the Clear Creeks Project and its workshops.

We are both transplants from other states, and we have long been committed to environmental preservation. But we had not realized what was at stake out here in Maryland regarding the Bay's overall health, and that what we are doing does really help. It's easy to feel helpless about improving the environment, but the information we received from the Gunpowder Valley Conservancy helped us be better stewards of the land."

A cornerstone of environmental education: Zion United Church of Christ in Perry Hall incorporated its rain barrels, rain garden, and edible Bayscape into its 2018 "Nature Explorers" vacation bible school. Having these Bay-Wise practices on-site helped the church serve as a community example of the positive things people can do to protect our local waterways.

A bridge between outdoor sporting and conservation:

Maryland State Game and Fish Protective Association in

Perry Hall and Baltimore County Game and Fish Protective

Association in Carney, Maryland have both enhanced their properties with conservation gardens and native trees and shrubs. Through educational signage, current and future members will learn how adding native plants to the landscape can provide beneficial wildlife habitat, as well as improve water quality for recreational opportunities.



REI PROVIDES GRANT SUPPORT FOR GVC FOR NEARLY A DECADE!



Recreation Equipment, Inc. (REI) has awarded over \$70,000 in funds toward the stewardship of GVC's Gunpowder watershed local waterways and restoration projects to increase wildlife habitat and improve water quality since 2008. Throughout the past 10 years, the GVC has partnered with the local REI Timonium Store in restoring areas of Gunpowder Falls State Park and Baltimore's Loch Raven Reservoir.

Projects supported include the planting of 2,500 native trees on 14 acres within Loch Raven Reservoir; and maintaining 7 miles of Loch Raven Reservoir and Gunpowder Falls State Park trails by installing 41 rolling grade dips, 8 water bars, removing 2,500 lbs of invasive plants and planting 1,491 native herbaceous shrubs through 30 Trail Maintenance/Invasive Removal workshops.

REI grants also supported tree maintenance of 2,172 REI planted trees by 143 volunteers, and GVC's Better Waterway fall clean-up events every November with total outcomes of 52,046 lbs of trash removed during 109 cleanup events by 1,310 volunteers.

In the past 8 years, nearly 3,000 volunteers, including those from REI Timonium, have provided close to 12,000 volunteer hours towards the restoration of the Gunpowder Watershed! REI remains supportive of GVC's education and restoration programs and continues to promote GVC events. Looking into the 2019 project year, the GVC will continue to build a corporate volunteer partnership with REI. We are grateful to REI for their long-term financial support and local store partnership this past decade contributing to the success of our education and restoration programs.






